

## AGENCIES REVIEWING COMP PLANS

Revised July 2009

Cities and counties need to send electronic copies of their draft comprehensive plans to the Washington State Department of Community, Trade and Economic Development (CTED), GMS Review Team, [reviewteam@cted.wa.gov](mailto:reviewteam@cted.wa.gov), at least 60 days prior to adoption (See, RCW 36.70A.106). If a jurisdiction only has hard copies available, it should mail a copy to each of the state agencies' representatives listed below, at least 60 days prior to adoption. Adopted amendments, including the final ordinance or resolution, should be sent to CTED, either by standard mail or E-mail, immediately upon publication, as well as to any state agencies that commented on the draft plan. A jurisdiction does *not* need to send its plan to those agencies that have been called first and indicated the local plan will not be reviewed. The jurisdiction should keep a record of these contacts with state agencies and the agencies' responses.
