Lead -Based Paint Program- Violators

Revised Code of Washington (RCW) 70.103.80 - The Department of Commerce may deny, suspend, or revoke a certificate for failure to comply with the requirements of this chapter, or any rule adopted under this chapter. No person whose certificate is revoked under this chapter shall be eligible to apply for a certificate for one year from the effective date of the final order of revocation.

Commerce Lead-Based Paint Program guidance policy includes the requirement for denial of certification for the one year period to those who are classified as uncertified violators.

- LBP – Lead-Based Paint Abatement: Certification of Worker, Supervisor, Inspector, and Risk Assessor disciplines, and their Firms
- RRP – Renovation, Repair, and Painting: Certification of Individual Renovators, and their Firms
