

Renovation, Repair, and Painting (RRP) Application for Registration of Certification

Revised August 10, 2016

USE THIS APPLICATION ONLY IF YOU ARE CURRENTLY CERTIFIED AS A RENOVATOR OR DUST SAMPLING TECHNICIAN BY EPA OR ANOTHER EPA-AUTHORIZED STATE.

Application fee is non-refundable. Contact us before submitting the application if you have a question.

Contractors performing renovation, repair, and painting projects that disturb lead-based paint in pre-1978 homes, child care facilities and schools must be certified and follow specific work practices to prevent lead contamination. This affects paid renovators who work in these facilities, including: renovation contractors, maintenance workers in multi-family housing, painters and other specialty trades.

Who should use this application?

Individuals who are currently certified as a Renovator or Dust Sampling Technician by another state, tribe, or EPA program and wish to work in Washington State.

Follow the steps below for completing the application process.

STEP 1

Complete the Application for Registration of Certification, Renovation, Repair, and Painting (RRP). Submit a separate application for each specialty (Renovator or Dust Sampling Technician). Each field on the application must be completed or marked 'N/A' for not applicable.

STEP 2

Review WAC 365-230 and become familiar with the requirements as they apply to individuals. Copies of the WAC are available on our website (www.commerce.wa.gov/lead).

STEP 3

Read and sign the Letter of Compliance on the bottom of the application form.

STEP 4

Mail your application with the required \$25 fee. The application must have an original signature. Copies are not acceptable. Send with check or money order made payable to Commerce to:
