### I. Introduction

The state of Washington has developed a new three-year State Implementation Plan and the format follows that of the *STOP Implementation Plan Checklist*.

The Washington State Office of Crime Victims Advocacy (OCVA) assembled the Violence Against Women Coordinating Committee with representatives from many different areas including victim services, prosecution, law enforcement, courts, Tribes, faith community, culturally specific and underserved populations. This committee meets to inform OCVA in matters related to violence against youth and adults and the priorities for spending these federal funds. From this meeting a multi-year plan was developed.

In accordance with the overarching goal of the STOP Grant to support a coordinated, multidisciplinary approach to enhancing advocacy and improving the criminal justice system's response to violent crimes against youth and adults, for the next three-year implementation plan covering federal awards 2014, 2015 and 2016, the state of Washington's priority continues to be directing resources to the local community level, where most victim services and criminal justice activities are planned and carried out including providing funding for culturally specific services and underserved communities. Washington State will continue to disburse the majority of the funds in a non-competitive process; however agencies who have historically under spent funding may receive a reduced award and unobligated funds will be directed to special projects as prioritized by coordinating committee members. The Court allocation will continue to be managed by the Administrative Office of the Court's Gender and Justice Commission. The Court allocation will fund projects selected from a competitive process and special court improvement projects including monitoring of sentencing for domestic violence

offenders and reviewing and updating domestic violence policies and procedures for courts of limited jurisdiction. The Washington State Implementation Plan was approved by the state on *February 12, 2014*. The Implementation Plan will cover three distinct grant periods beginning January 1, 2015 and ending December 31, 2017.

# II. Description of Planning Process

Washington State's Violence Against Women Coordinating Committee serves as a multidisciplinary planning team. Members include representatives from non-profit, non-governmental domestic violence and sexual assault agencies, prosecutors, courts, Tribes, faith community, law enforcement, agencies established to provide services by and for marginalized populations, the statewide domestic violence coalition, sexual assault coalition, Tribal coalition, crime victim advocates coalition, statewide associations of prosecuting attorneys and sheriff and police chiefs, hospital based SANE program, and staff from the state departments of Health, Corrections, and Social & Health Services. The planning team includes representation from 20 community-based victim services organizations to ensure meaningful participation and input into the plan. Approximately 40% of the team members are directors and program managers from nonprofit non-governmental domestic violence and/or sexual assault agencies.

Members from many diverse communities are part of the planning team and provide a great deal of input into the process. The State's Implementation Plan reflects priorities in services to diverse and underserved communities. The committee continues

to seek membership from both underserved and culturally specific communities. The planning team has representatives from communities of color and Tribes.

In preparation of creating a new three-year plan, information was provided to the committee prior to the meeting to help inform the planning process. Information consisted of results from a statewide survey, and highlights of new requirements with VAWA 2013. Data was analyzed and distributed to planning team members.

### [Attachment B: Survey Results]

A meeting was convened to discuss the state's three-year Implementation Plan. The committee also briefly discussed projects funded through the Grants to Encourage Arrest Policies and Enforcement of Protection Orders Program. The meeting was facilitated to allow for open and respectful dialogue across disciplines and decisions were reached by consensus. Representatives from twenty community-based domestic violence and sexual assault organizations along with staff from the four statewide coalitions contributed significantly to guiding the development of Washington State's three-year Implementation Plan. In addition, eight of the community-based agencies represented rural areas of the state. [Attachment C: Committee Meeting Agenda]

Much of the planning meeting discussion centered on the funding allocation and priorities. A portion of the meeting included a presentation related to new requirements of VAWA 2013 and an overview of Washington State's domestic violence fatality review report recommendations. Tribal representatives were able to assist committee members in identifying both the challenges and barriers Tribal victims must overcome to secure assistance. Committee members were encouraged to consider Tribal sovereignty when

addressing the needs of Tribal communities. The final phase of the planning process includes:

- Distribution of a summary of input provided at meeting for committee review and comment;
- Draft Implementation Plan distributed by email for review and comment;
- 2<sup>nd</sup> Draft Implementation Plan distributed (if needed) by email for review and comment; and
- Final Implementation Plan distributed by email along with the Documentation of Collaboration form. [Attachment D: Documentation of Collaboration]

# Coordination of Plan with FVPSA, VOCA and RPE State Plans

<u>Coordination with Family Violence Prevention and Services Act Plan</u> – The state administrator for the Family Violence Prevention and Services Act is a member of our planning team and participated in the development of Washington State's Implementation Plan. Our process of a non-competitive based distribution for the STOP Formula Grant aligns with the priority of Washington's FVPSA funding to provide consistent and stable resources statewide using a formula based method to support emergency domestic violence shelters. The STOP funding will complement advocacy services at most of the domestic violence shelter programs across the state.

<u>Coordination with Victims of Crime Act and Rape Prevention Education</u> – In addition to administering the STOP Formula Grant, the Office of Crime Victims Advocacy is also responsible for managing the victim assistance portion of VOCA and through an interagency agreement with the Washington State Department of Health, provides management of the RPE funding. Our STOP Implementation Plan aligns with the VOCA

Plan by sharing a philosophy of ensuring quality services are provided to victims in every county. The base allocation for VOCA is also distributed through a non-competitive formula based method. STOP Grant funding will complement services supported with the VOCA Victim Assistance allocation. The RPE State Plan focuses on maintaining community-based sexual assault prevention activities on a statewide basis through accredited community sexual assault programs, many of which also receive STOP funds. RPE is mainly distributed through a sexual assault services funding formula, however, a small amount is allocated to a set aside for a select number of prevention projects. Additionally, the RPE State Plan supports primary prevention work of culturally specific agencies.

# III. Needs and Context

Washington State's estimated population as of April 1, 2013 was 6,882,400 making it the 13<sup>th</sup> most populous state in the country.

Seven of the ten most populous cities are located on or near the Interstate-5 corridor in Western Washington. Yakima is located in Central Washington, Spokane and Spokane Valley are located in the far Eastern part of the state. Approximately 30 of Washington's 39 counties have a population density of less than 100 persons per square mile.

Washington State's population includes:

American Indian and Alaskan Native (1.3%) Asian (7.1%) Black or African American (3.4%) Hispanic or Latino origin (11.2%) Native Hawaiian and Other Pacific Islander (0.7%) 2 or more races (3.6%) White (72.7%)

The Northwest Immigrant Right's Project, based in Seattle, has noted that Washington State is one of the top refugee resettlement states in the country and trends show foreign-born residents continuing to increase. Currently, one in six residents of Seattle is foreign-born. Approximately half of the State's population is female and 73.7% of the population is over the age of 19.

While limited services exist statewide, rural areas are most affected with fewer resources than urban parts of the state. Barriers to services are greater in rural areas due to reduced transportation, limited language translation services and not enough staffing resources. There are fewer medical facilities and SANE services and response times are longer for law enforcement in rural areas.

# IV. Plan Priorities and Approaches

# A. Identified Goal

Washington State has an overarching STOP Grant goal of *increasing the safety of youth and adults by supporting communities in developing comprehensive and collaborative strategies to address domestic violence, sexual assault, dating violence and stalking; and to prioritize the needs and safety of victims while holding offenders accountable for their crimes.* This goal will be supported by the following funding strategies:

 fund community based culturally specific agencies and Tribes to provide services primarily directed toward racial and ethnic minority communities;

- fund community driven initiatives that are responsive in addressing the needs of underserved populations;
- fund law enforcement and prosecutorial agencies to actively engage in a coordinated response to violence against youth and adult victims of domestic violence, sexual assault, dating violence or stalking;
- fund judicial training and the development of appropriate policies and protocols that hold offenders accountable while ensuring sensitivity to victim needs;
- fund services that assist and provide support to victims of domestic violence, sexual assault, dating violence, and stalking;
- fund the planning and implementation of activities that meaningfully address sexual assault;
- fund prevention related initiatives, as communities determine need but no more than 5% of the state's STOP allocation; and
- fund local community activities aimed at reducing domestic violence related homicides.

### **Strategy for Reducing Domestic Violence-related Homicides (see Table 3)**

A new emphasis with this implementation plan includes a more focused goal of reducing domestic violence-related homicides by encouraging CCR teams to promote and increase prevention activities in school settings, at medical facilities, through county health departments, and within the criminal justice response. This goal will be supported using the following strategies:

 utilize lethality risk assessment as a screening tool within law enforcement and criminal/family court systems;

- identify and address language barriers experienced by victims when accessing community and system-based services;
- establish procedures and protocols regarding firearm seizure and storage;
- host violence prevention activities in schools or other youth events; and
- partner with faith and medical communities in providing education and awareness.

#### **B.** Priority Areas

Based on the recommendations from the state's planning team, it was determined that continuing with a formula based distribution supports the priority and commitment that victims have access to services in every community while also fostering a coordinated response. The following priorities will support victim services and enhance the criminal justice system's response to youth and adult victims of sexual assault, domestic violence, stalking and dating violence in Washington State:

- A non-competitive formula based application process to local communities will continue for a large portion of the law enforcement, prosecution, and victim services function areas with an emphasis on reducing domestic violence related homicides, where appropriate;
- At least 10% of the funds for victim services will be distributed to culturally specific community-based and tribal agencies;
- 3) Through an interagency agreement with the Washington State Administrative Office of the Courts, an allocation of at least 5% of funding will be distributed by the Washington State Gender and Justice Commission, to support projects selected through a competitive process as well as statewide initiatives;

- At least 4.75% of the victim service (not culturally specific) allocation will support advocacy services to help meet PREA compliance requirements;
- Approximately 26% of the VAWA mandated allocations for law enforcement, prosecution and courts will support planning and implementation of activities that meaningfully address sexual assault; and
- Unspent allocations will be directed to special projects as prioritized by the planning team.

Washington State's three-year Implementation Plan will continue to address findings from the Washington State Coalition Against Domestic Violence's Fatality Review. Specifically, coordinated community response teams will be encouraged to promote and increase prevention activities with a goal of reducing domestic violence related homicides. Our STOP funding currently provides and will continue to provide support for advocates working with culturally specific communities and Tribes. The plan also prioritizes funding to enhance services for victims of sexual assault.

Washington State's Implementation Plan will not address the "Crystal Judson" purpose area. Washington State has passed legislation specific to law enforcement involved domestic violence and already requires departments to have training, policies and procedures in place.

### **General Description of Projects**

## Victim Services, Law Enforcement, Prosecution, Courts and Discretionary:

Washington State continues to grant with more than 90 agencies using STOP Grant funds. [Attachment E: STOP Grant Grantees] The following provides a brief description of projects funded with the STOP Grant:

- Law enforcement projects that focus on providing continuing education for officers including how to enforce applicable laws for victim safety and offender accountability, evidence collection, and procedures to promote victim safety.
- Prosecutorial projects that focus on providing special investigators and victim assistance staff. Projects that expand hours of current staff and enhance support to victims on cases involving youth and adults as well as to maintain bilingual victim advocate staff to provide support to people with limited English speaking proficiency. Other projects that provide multidisciplinary training to city, county, and tribal prosecutors.
- Victim service organizations that continue to provide direct services to youth and adult victims of sexual assault, domestic violence, stalking and dating violence.
   Direct services that include therapy and/or support groups, legal advocacy, assistance with immigration issues, information and referral, crisis intervention, support for shelter coordinators and advocates. Additionally, funds will support advocacy services provided by culturally specific agencies and Tribes.
- Court funding that supports statewide projects or initiatives, as determined by the Washington State Gender and Justice Commission that will improve the judicial response to domestic violence, sexual assault, dating violence and stalking.

Projects could include training of judicial personnel on utilizing lethality risk

assessment tools during protection order hearings and updating of court

procedures related to victim safety.

Discretionary allocation that continues to support 5% of the law enforcement and

5% of the prosecutor activities listed above. Washington State uses 10% of

discretionary funds to supplement the formula allocation to law enforcement and

prosecutors, bringing them each to 30%. Five percent of the funds will support

additional advocacy services to victim service organizations.

A non-competitive formula based application process to local communities will continue for the law enforcement, prosecution, and victim services function areas. A portion of the law enforcement and prosecution allocation will be set aside for an application process to support projects that meaningfully address sexual assault. A portion of the victim services funding will be used to help meet PREA compliance by supplementing a state allocation to be distributed using a formula-based model to community-based sexual assault programs in or near counties with correctional facilities under the operational control of the Governor's Office. Through an interagency agreement with the Washington State Administrative Office of the Courts, funding will be distributed by the Washington State Gender and Justice Commission, to support projects selected through a competitive process as well as statewide initiatives.

Unspent allocations will be directed to special projects as prioritized by the planning team which could include underserved and/or communities of color. Funding may support projects such as legal services for undocumented victims, outreach and education to persons who are HIV positive, assisting tribal programs, and training to faith communities. [Attachment F: Letters Documenting Need] Progress toward Sexual Assault Set-aside

In previous years, approximately 18 to 20 percent of Washington State's STOP allocation supported services and training to improve the community response to victims of sexual assault. Beginning with our next grant cycle (January 1, 2015) we will support victim services to incarcerated victims using at least 4.75% to assist the State in achieving full compliance with the PREA standards. We will continue to support sexual assault services such as legal and medical advocacy, therapy, support groups, and crisis intervention through our formula grant allocation (approximately 21%) to victim services at the local level. Additionally, a portion (approximately 26%) of the law enforcement and prosecutor allocation will be set aside to be distributed through an application process to select projects that meaningfully address sexual assault. Through an interagency agreement with the Administrative Office of

the Courts, at least 26% of their allocation will support judicial projects or initiatives that meaningfully address sexual assault by improving the court's response to cases.

These strategies ensure at least 20% of the state's STOP allocation support sexual assault specific projects across two or more allocation/function areas.

### C. Grant-Making Strategy

Washington State's process was determined based on the feedback received from the Violence Against Women Coordinating Committee whose members include law enforcement, prosecution, victim services, and courts. There was overwhelming support from committee members to continue the original formula structure along with some new efforts. The base funding for each county will continue to be \$45,000 and add-ons are done by the following formula: **population + square miles**.

Approximately 80% of the funds will be allocated to local communities to implement plans they develop to strengthen their community's response including identifying and implementing activities aimed at reducing domestic violence related homicides. Every other funding cycle requires local plans to be developed through a collaborative process that at a minimum includes representatives from law enforcement, prosecution and victim services but also encourages participation from courts, Tribes, medical, and faith communities as well as other social services organizations. These local plans must address issues related to serving victims of sexual assault, domestic violence, dating violence and stalking, including Tribal Nations, underserved populations, and communities of color.

In keeping with the State's support of services to all counties, communities will not be required to compete against each other for the larger portion of the victim

service, law enforcement and prosecution pass-through funds, but will be guaranteed access to a known number of dollars based on a distribution formula. Each county will be eligible to receive a base amount, which will be equal for all counties.

The base amount is established so that every county, regardless of size or population, will be able to create or enhance activities that will have a discernible impact in their communities. This formula-based funding ensures that a diverse group of urban, non-urban, and rural communities all benefit from the resources provided through the STOP Grant.

An additional amount will be added to the formula based upon the percentage of the State's total population residing within that county's borders and the percentage of the State's total land area within that county's borders. Amounts may be adjusted to reduce the allocation for an agency based on historic under spending. STOP Grant subrecipient awards to victim services, law enforcement agencies, prosecutors, and courts will continue on a one-year grant cycle of January 1 to December 31.

In Washington State the STOP Grant promotes collaborative relationships among key players in an effort to support comprehensive strategies that are sensitive to the immediate and long-term needs and safety of victims/survivors of sexual assault, domestic violence, stalking and dating violence. Planning team members continue to be concerned that these relationships might be impaired if an equal split in the allocations is not maintained.

### **Consultation with Victim Services**

In order to ensure that proposed activities are designed to promote the safety, confidentiality, and economic independence of victims of domestic violence, sexual assault, stalking and dating violence, a requirement of applications for funding will continue to include a form that documents the consultation of criminal justice partners with community-based victim service providers. This form documents the review and approval by victim services of all proposed activities.

Please note that the manner in which Washington State distributes the STOP Grant funding would make it almost impossible, as well as cumbersome on subgrantees to require a letter or other documentation from each organization prior to the release of the application for funding. [Attachment G: Consultation with Victim Services Form]

### D. Addressing the Needs of Underserved Victims

Over 75% of Washington State's counties are rural and continue to face unique challenges. Barriers to services are greater in rural areas. In addition to limited options for transportation, there are also fewer medical facilities and SANE services. Victims can be isolated and unable to discreetly access services. Response times are also longer for law enforcement in rural areas. Washington State's formula distribution ensures a base amount for each county to provide stable funding for staff, criminal justice training, transportation costs, and other locally identified needs such as SANE trainings, services for immigrant victims, and law enforcement well checks.

Washington State's Plan includes at least 10% of the victim service funding allocation for community-based culturally specific agencies and Tribes. Sub-grantees

may include: Korean Women's Association, API Chaya, Consejo Counseling and Referral Services, Refugee Women's Alliance, Lummi Nation, Swinomish Tribe, and Nisqually Tribe. These funds will be distributed equally through a streamlined application process to culturally specific victim service providers meeting the following criteria:

# Applicants/recipients must:

- be a culturally specific victim service agency or be a federally recognized tribe with an existing Domestic Violence Code;
- maintain a program whose primary focus includes providing emergency services, advocacy, or counseling for victims of domestic violence, sexual assault, stalking, or dating violence;
- ensure that crisis intervention is available 24 hours a day, seven days a week;
- provide direct advocacy services for their clients;
- understand that while some services may be delivered over the telephone, it
  is an expectation that during regular hours of operation in-person services are
  available; and
- use these funds to employ an advocate whose primary focus includes culturally relevant and linguistically specific services for youth and adult victims of domestic violence, sexual assault, stalking or dating violence.

Unspent allocations will be directed to special projects as prioritized by the coordinating committee members, which could include underserved and/or culturally specific communities. Priorities identified include funding to support:

legal services for undocumented victims;

- victims who are HIV positive;
- Tribal programs;
- veteran and military families;
- victims in institutions including nursing homes, hospitals, or care centers;
- victims who are homeless; and
- faith-based services.

The state of Washington's Office of Crime Victims Advocacy (OCVA) partnered with a work group called Community Voices whose members represented communities that have historically been marginalized by the dominant culture. In September 2002, their first report entitled, *Community Voices*, was released and clearly illustrated the gap between the original philosophy through which the Community Sexual Assault Programs were created and day-to-day experiences of marginalized communities. As a result of their report OCVA adopted a justice imperative to recognize where privilege exists and address its effects on services to victims in marginalized and underserved communities.

In 2008, Community Voices released a second report to OCVA highlighting changes and needs for services in marginalized communities. As part of the report, Community Voices members conducted an extensive survey. The survey indicated a great desire by members of marginalized communities for services in agencies which were culturally and linguistically accessible, culturally competent, and culturally familiar. While the results indicated that OCVA's existing programs had done a credible job in serving some marginalized victims, it also found that all of the communities around the state reported a need for more information, and more services *by and for* marginalized communities. Our STOP funding strategy, in keeping with these findings, continues to support, fund and encourage services provided by culturally specific agencies.

### E. Monitoring and Evaluation

### Success of project activities will be evaluated as follows:

- Victim services: increased services available through community driven initiatives that are culturally responsive to victims; increased services provided to victims of sexual assault, stalking, domestic violence, and dating violence; and enhanced collaboration between mainstream organizations and culturally specific agencies. Success will be measured using annual report forms and through monitoring of participation in quarterly CCR team meetings.
- Law enforcement: calls for assistance in cases of sexual assault, domestic violence, stalking, dating violence and violations of protection orders compared to number of investigations of these calls and the number of cases referred to the prosecutor; increased number of officers receiving specialized training on topics such as services to victims of sexual assault, stalking issues, and evidence collection. Success will be measured using annual report forms and through monitoring of participation in quarterly CCR team meetings.
- Prosecution: tracking of sexual assault, domestic violence, stalking, dating violence and protection order violation cases received compared to number of charges filed for these cases; comparison of how many of these cases were dismissed, convicted or acquitted; an increased number of prosecutors receiving specialized training, such as, sexual assault or stalking; and an increase in the

number of services or number of clients served by victim/witness coordinators. Success will be measured using annual report forms and through monitoring of participation in quarterly CCR team meetings.

 Courts: increased education and training around the issues of sexual assault, domestic violence, dating violence, and stalking to all courts. The Gender and Justice Commission administers the court funds and success will be measured using annual report forms.

Program staff will monitor the progress of projects through a pre-grant risk assessment, on-site visits, and data progress reports. OCVA's grant monitoring consists of reviewing back-up documentation for all Goods & Services purchased with STOP Grant funds and conducting annual non-program related risk assessments distributed to all Department of Commerce grantees and biennial program risk assessments.

As in prior years, counties must have a coordinated community response team and those receiving funds are required to participate in the team's meetings. All teams are required to meet at least quarterly. OCVA will continue to offer and provide technical support to the teams and monitor their work. In addition, OCVA encourages teams to identify unmet needs in their county and involve Tribes and agencies serving victims from marginalized and underserved communities to participate.

# V. Conclusion

Using the strategies listed earlier, an application will be developed and distributed to each community with a requirement that all local plans continue to promote the goal of victim safety. In summary:

- Approximately 80% of the pass-thru funding will continue on a non-competitive formula based application. Funds will be allocated in an equal percentage to law enforcement, prosecution, and victim services.
- A portion of the law enforcement and prosecutor allocations will be set aside to support projects that meaningfully address sexual assault.
- A portion of the victim services allocation will support sexual assault advocacy services to victims who are incarcerated.
- Court projects will be administered by the Administrative Office of the Courts to enhance the role of judicial and other court personnel in securing victim safety through judicial education and court related projects.
- Unspent funding will be made available for special project including statewide impact projects as supported by a sub-group of planning team members.
- Funding will also support projects enhancing advocacy services provided by culturally specific agencies and Tribes.

It continues to be our belief that when there is increased collaboration between law enforcement, prosecution, judiciary, and victim services, the criminal justice system works more effectively for women which in turn increases the safety of women in every community. *Regardless of the project, all activities will be required to support the goal of victim safety.*  Attachments


Should OCVA distribute the Victim Services allocation through a formula-based or competitive process?


Should OCVA distribute the Prosecution allocation through a formula-based or competitive process?






Should OCVA distribute the Law Enforcement allocation through a formula-based or competitive process?









Should OCVA continue to supplement Law Enforcement funding with discretionary funds?


Should the 20% for sexual assault services be distributed to local projects or statewide projects?

Distribution of STOP Formula Funds in Washington	Our state has historically used a 30/30/30 split for law enforcement, prosecution and victim services with the remaining funds going to courts (5%) and the other 5% to discretionary which is used for special projects. We surveyed members of our state's STOP Coordinating Committee, our grantees and other relevant stakeholders about the option of continuing this formula for the three primary disciplines and courts or moving to a new distribution model, possibly competitive, for the next three-year implementation plan. Feedback demonstrated overwhelming support for continued formula-based non-competitive distribution of the 30% for law enforcement, 30% for prosecution and 30% for victim services. The 5% court allocation would continue to be managed by the Administrative Office of the Courts through a combination of competitive grants, training for judges and special statewide projects. Discretionary funding will be used to help meet PREA compliance.	There was discussion initiated by committee members about a competitive model, but as the discussions continued, a consensus was reached to keep the formula non- competitive distribution model we currently use. Most of the committee echoed the results of the survey which indicated overwhelmingly to maintain the non-competitive, formula based distribution method.
PREA	If approved by OVW, 5% of the formula funds will be set aside to help meet PREA compliance by supplementing a state allocation to be distributed using a formula-based model to community-based sexual assault programs in or near counties with correctional facilities.	
20% Sexual Assault Funding	Beginning with the FFY 2016 STOP award, at least 15% of each function area's allocation will be used to support planning and implementation of activities that meaningfully address sexual assault. Pending OVW's clarification of the PREA requirement, 5% of the FFY 2014 allocation will be used to bring the state into compliance by supporting community-based advocacy for incarcerated victims of sexual assault.	

# **Summary of Issues Raised**

Culturally Specific and Underserved Populations Prioritization	At least 10% of the funds for nonprofit, nongovernmental victim services will be distributed to culturally specific community-based agencies. Agencies currently eligible to receive this allocation with FFY 2014 funding are: Korean Women's Association, API Chaya, Consejo Counseling and Referral Services, Refugee Women's Alliance, Lummi Nation, Swinomish Tribe, and Nisqually Tribe. This allocation will be distributed equally through a streamlined application process.	There was discussion of a set aside allocation for tribes. It was determined that with the addition of the PREA requirement, there would not be enough funding for a set aside. However, the committee agreed that in addition to receiving a portion of the 10% culturally specific allocation, it was also important to include tribes to a priority list for unspent funding.
Unspent Distribution Options	The plan includes priority areas identified by the committee where any unspent or returned funds from subgrantees could be redistributed. A sub- group of committee members will be consulted to determine highest priority as funds become available.	There was discussion of distributing unspent funds in a competitive process, but once discussed further, it seemed that the prioritizing of projects model would serve the purpose better as the amount returned is not historically enough to have a major impact on multiple projects especially after putting resources into the competition process.





#### Hi Dee,

Thank you so much for completing and returning the Documentation of Collaboration form required for our next threeyear Implementation Plan. I wanted to follow-up with you on the last question. Your comment mentions that currently only 3 of 29 tribes are eligible for funding. Actually, any tribe meeting the requirements for domestic violence legal advocacy funding is eligible for STOP funding. The STOP funding has been used to supplement state funding specifically for domestic violence legal advocacy and as such, the tribe must meet some minimum requirements as noted in the Implementation Plan (Page 9). Every other year the application process is opened and any of the twenty-nine tribes can submit an application for funding. It has been the choice of some tribes, although eligible, not to apply. Additionally, you'll notice that in the new Implementation Plan, we've listed tribes as a priority of funding for any unspent allocations. Our intention is to support tribal projects related to sexual assault, domestic violence, stalking and/or dating violence as funding becomes available beginning with the FFY 2014 federal allocation regardless of whether they receive state funding to support a domestic violence legal advocacy program. We will seek input and guidance from the WomenSpirit Coalition and other tribal committee members as we review any related requests for funding.

As we've discussed previously, we are hopeful that your outreach will increase the number of tribes interested in applying for funding under the domestic violence legal advocacy program as well as any available STOP Grant allocations. I hope this addresses your concerns. Again, thank you for your participation in the development of the next three-year STOP Formula Grant Implementation Plan. Take care. Pearl-

I am the Staff Attorney for the Washington Association of Prosecuting Attorneys, and have I serve as a representative on the Washington State's Violence Against Women Coordinating Committee.

VAWA funds led in recent years to full time victim-witness coordinators within prosecutor's offices, domestic violence, victim-witness, and criminal procedures brochures in English and Spanish language, the purchase of lap top computers for court presentations, new police and prosecutor policies for investigating, arresting, and charging domestic violence cases, and safe waiting areas for victims and their children.

However, there is still room for improvement in our services to women who have been victimized by violence through increased training and idea sharing among law enforcement, prosecution and victim services. Many officers, prosecutors and victim advocates have never participated in multi-disciplinary trainings. Many prosecutors and police officers need education on stalking and human trafficking.

Society's current attitude towards violence against women is unacceptable. A more comprehensive, consistent approach to cases involving violence against women that integrates law enforcement, prosecution, and victim services, can lead to an increase in the number of victims initiating and following through on criminal justice cases. Women over the age of eighteen, from all racial, ethnic, language and disability backgrounds, would reap the benefits of such an approach.

We are an active member of the Community Coordinated Respond Team (CCRT) in working together with our local advocates, city prosecutors and law enforcement agencies in educating the community on sexual assault, domestic violence, child abuse and teen dating. I am the Chief of Police for the Aberdeen Police Department located in rural Grays Harbor County, Washington. I am pleased to have the opportunity to express my support for the continued funding of the STOP Violence Against Women Program in the State of Washington. The City of Aberdeen Police Department is unique in that in addition to administering law enforcements STOP allocation, we also administer the STOP funding portion for prosecution.

The approach taken by our county has been very effective. STOP funds have been used to develop, train and support a specialized team of officers to respond to victims of domestic violence, sexual assault or stalking. With STOP funds we were able to provide training to law enforcement and other disciplines in the area of Human Trafficking, Domestic Violence, and Marginalized Communities. The funding has allowed the city to provide for a witness victim coordinator for the prosecutor's office. We are able to engage the victim and assist them through the local court system. By this enhancement we are further able to hold perpetrators accountable for the action. In year the 2013 we have had over one hundred and ninety eight (198) calls for service regarding domestic violence, our Domestic Abuse Response Team (DART) has handled over seventy two (72) cases, and over sixty nine 69 protection orders have been issued and forty seven (47) violators of protection orders were arrested. Victims were given information on other resources available to assist them. In summary STOP grant funding has improved the quality of cases for prosecution and enhanced law enforcement's primary role in stopping the cycle of violence.

This year, we hope to continue ongoing trainings for personnel and continued advocacy efforts. Like most states, counties, and cities the current economic times will impact our small rural community severely. Continued funding in FFY 2014 is vital for our continued success in meeting the needs of females eighteen and older from all social, racial, ethnic, national origin, disability and cultural backgrounds in rural Aberdeen.

I am writing this letter in support of Washington State's application for FY2014 STOP Violence Against Women Formula Grant Program funds. Family Resource Center (FRC) is the agency which provides STOP victim services to in Lincoln County, Washington. We have been providing these services for the past 23 years. Although our faces at FRC haven't changed much, the faces in Prosecution and Law Enforcement have changed thus making this grant an essential piece of what helps us coordinate services for victims together as a team.

FRC is located in the very small frontier agricultural land of Lincoln County with a population of 10,000 people covering a radius of 2300 miles. Farms and ranches range in size from several hundred acres up to about ten thousand acres. In between the farm and pasture lands are eight towns with populations ranging from a couple hundred to twelve hundred people. Our county consists of mostly Caucasians with our northern county lines bordering two Native Tribal Reservations. Native children attend school in two of our towns, so Native women access our services. Thirty percent of our populations are senior citizens and we have a large population of those who are disabled.

We need this grant for many reasons. High on our priority list is the Coordination of Prosecution, Law Enforcement and Victim Services into our Coordinated Community Response Team (CCRT); this requirement ensures that we WILL meet as a Team. Our STOP Grant funds are used for victim advocacy services, the CCRT, training advocates and for counseling stipends to adult women victims of domestic violence, sexual assault and stalking.

Our CCRT is working better together; these funds have helped us get to this place. Although we at FRC believe we have a ways to go before all of our members "get it" in regards to what it takes to keep women safe from violence, we are moving in that direction to that goal. We know that the CCRT is our driving force to that goal. This program puts us all at the table; without this program there is no equal meeting ground. We need the STOP Grant.

Thank you for the STOP Grant funds in the past. We are hopeful that Washington State will be awarded the grant again and we will be able to continue our work through this needed funding source. Please consider what others and I have shared about the STOP Grant funds within Washington State. Thank you for your time and consideration.
