Overview



Program overview

- **Advance the goals of the 2021 State Energy Strategy**
 - Decarbonize the buildings sector
- **Desired outcomes include:**
 - Reducing greenhouse gas emissions from buildings
 - Accelerating the path to zero-energy buildings
 - Demonstrating early adoption of grid integration technology
- **Eligible projects include but are not limited to:**
 - Shifting from fossil fuels to high-efficiency electric heat pumps and other electric equipment
 - Control systems that enable grid integration or demand control
 - On-site renewable generation and efficiency measures that significantly reduce building energy loads

Program objectives and scope of work

- **Building electrification projects that:**
 - Demonstrate innovative approaches to deploying and increasing access to grid integration technology
 - Reduce energy use and greenhouse gas emissions from new and existing residential and commercial buildings
 - Advance technology solutions to accelerate the deployment of zero-energy, all-electric buildings
 - Support the integration of distributed energy resources

Program project tracks

- Applications will be evaluated under two tracks
 - Grid-Interactive Buildings
 - Electric Equipment and Fuel Switching
- Each applicant can only submit **one** application for a Track 1 project and **one** application for a Track 2 project

Program project tracks

Track 1: Grid-Interactive Buildings	Track 2: Electric Equipment and Fuel Switching
<ul style="list-style-type: none">• Install grid-interactive control systems that allow building or electric grid operators to reduce, shift or modulate building energy use• Must partner with the local retail electric utility to demonstrate, or enroll in, a grid-integration utility program• New or existing buildings	<ul style="list-style-type: none">• Install high-efficiency electric heat pumps or other equipment to replace or reduce use of existing fossil fuel systems or inefficient equipment or systems• Projects may install other measures to reduce energy use to accompany high-efficiency electric equipment or systems• Existing buildings

Program project tracks – eligible expenses

Track 1: Grid-Interactive Buildings	Track 2: Electric Equipment and Fuel Switching
<ul style="list-style-type: none">• Grid-interactive control systems and other smart technologies• Labor costs to install, commission or distribute such technologies• Defined percentage of program administration costs for program administrators	<ul style="list-style-type: none">• High-efficiency electric equipment or systems• Other measures to reduce energy use to accompany high-efficiency electric equipment or systems• Labor costs to install, commission or distribute such equipment and technologies; or decommission or remove existing equipment• Defined percentage of program administration costs for program administrators

All track requirements

- Grants funded under both tracks **must** meet the following:
 - Projects completed within 24 months of execution of the contract
 - Provide workforce development opportunities
 - Submit rent increase schedule for applicants with low-income tenants
 - Provide all tenants with information about the project and the option to opt out or receive mitigation if energy costs increase

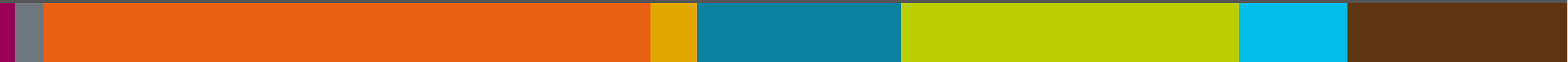
All track priorities

- **Commerce prioritizes projects that achieve the following:**
 - Reduce energy burden
 - Located in highly impacted communities
 - Reduce GHG emissions – reduce cost per ton of GHG emissions
 - Demonstrate meaningful community engagement or co-creation
 - Include letter of support from a low income weatherization program
 - Demonstrate hard-to-electrify technology solutions, new technology or other innovative approaches

All track ineligible activities

- Fleet electrification or standalone EVSE
- Energy efficiency measures or on-site renewable energy systems that are not installed as part of the minimum scope of work
- Acquisition or development of off-site renewable energy systems or purchasing RECs or carbon offsets
- Project site acquisition or selection activities
- Grant proposal development for future state or other funding applications

Minimum Qualifications



Who can apply?

- **Primary eligible applicant must be one of the following:**
 - **Building owner or tenant** of a multifamily residential or commercial building
 - Tenants must occupy at least 50% of the units or gross square footage of the building, with a letter of support from the building owner
 - Owner or tenant must not participate in a program administered by another eligible applicant receiving funding under this solicitation
 - **Program administrator** serving multiple retail electric utility customers in Washington

Who can apply?

- **Building owner or tenant includes:**

- State and local government
- Federally recognized tribal government
- Housing authority
- 501(c)(3) non-profit
- For-profit company
- Individual owner of multifamily residential or commercial building

- **Program administrator includes:**

- 501(c)(3) non-profit
- Local government
- Federally recognized tribal government
- Housing authority
- Retail electric utility

Who can apply?

- **Licensed to do business in the state of Washington**
 - Commit to becoming licensed within 30 calendar days of selection as the Apparently Successful Grantee
- **In good standing with all applicable federal, state and local laws and requirements, including with Commerce**
- **See RFA Section 1.3 for definitions**

Minimum project qualifications

- Located at one or more new or existing single-family, multifamily, or commercial buildings owned or leased by an eligible applicant located in Washington
 - Include at least 50% of the total units or gross square footage
- Administer a program that serves multiple retail electric utility customers in Washington
 - Work performed at one or more new or existing single-family, multifamily, or commercial buildings

Minimum project qualifications

- Projects proposed for existing buildings must agree to not increase rents for existing tenants due to improvements funded by this program
- Demonstrate commitment to completing the minimum scope of work for the corresponding application track, as defined in RFA Section 1.2

Minimum qualifications and your application

- All of the listed minimum qualifications must be met to advance to application scoring
- Application must be complete with all mandatory attachments and complete the application form for your application track

Application contents

- **Applicant summary**
 - Information about the applicant and proposed subcontractors
- **Project summary**
 - Information about the proposed project
- **Technical proposal**
 - Technical information, including emissions reductions
- **Equity narrative**
 - Energy burden reduction, community engagement and rent provisions
- **Management proposal**
 - Work plan, estimated schedule and risks
- **Cost proposal**
 - Match, identification of costs and budget narrative

Application contents

- **Additional documents**
 - Certifications and assurances (Mandatory)
 - Diverse business inclusion plan (Mandatory)
 - Workers' rights certification (Mandatory, Scored)
 - Project site information (Mandatory, Scored)
 - Partner letters of support (Optional, Scored)
 - Owner's letter of support (Mandatory, Not scored)
 - Letter from retail electric utility (Mandatory) (*Track 1 only*)
 - Low-income weatherization program provider letter of support (Optional, Scored)
 - OMWBE Certification (Optional, Not scored)

Equity narrative

- **Describe how the project ...**
 - Reduces energy burden, including specific project cost figures dedicated to priority communities
 - Meaningfully addresses barriers to equity and inclusion in adoption of building electrification technology
 - Provides workforce development opportunities during and after project deployment
 - Has or will engage priority communities
- **Applicant agrees to not increase rents for existing tenants**
- **Tenant provisions to mitigate increases to tenant energy costs**

Evaluation of applications

- **Policy priorities**
 - Commerce prioritizes project that align with state policy goals
- **Workers' rights certification**
 - 3% bonus to overall score
- **RFA sections**
 - Policy Priorities – Section 1.2
 - Scoring Criteria – Section 4.2

Scoring categories:

Category	Points available
Equity & Energy Burden Reduction	120
Technical Innovation	60
Emissions Reductions	90
Management Proposal	40
Total Points Available	310

Funding



Available funding

- **\$9.7 million total across both tracks**
 - \$4,850,000 initially reserved for Track 1
 - \$4,850,000 initially reserved for Track 2
 - Commerce may choose to allocate funding for one track to the other if funding remains after reviewer recommendations
- **Only 1 award per applicant per application track**
- **Minimum award: \$50,000 / Maximum award: \$1 million**
 - Applications not within these amounts will not be evaluated
- **Refer to RFA Section 1.4 for more information**

Match

- Applicants must have minimum match funding from other, non-state sources
 - Program administrators may use program participant matching funds
- Match funds must be secured before contract execution
- Commerce will adjust the award to meet the minimum match requirements

Match

- Reduced match based on the percent of total project costs dedicated to reducing energy burden for priority communities, low-income/affordable housing, low-income households, or organizations or businesses serving these populations

Eligible applicant	Match ratio	Match based on percent of total project costs dedicated to energy burden reduction		
		Match ratio with 10% - 25%	Match ratio with 26% - 75%	Match ratio with more than 75%
Federally recognized tribal government	1:10	1:10	1:10	1:10
K-12 public school districts (local government)	1:5	1:5	1:5	1:10
All other eligible applicants	1:3	1:4	1:5	1:10
